CIRCULAR

Applications are invited from all the eligible teachers working in various Departments of NNM (Deemed to be University), who are due for promotion **in the next Academic Level/Grade Pay** under Career Advancement Scheme in accordance with University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2010 & 2018.

The applications alongwith five sets of PBAS Proforma (**available on the NNM official Website**) as prescribed by the University Grants Commission vide its Regulations, 2010 & 2018 duly forwarded by the concerned Head of the Department should reach the Establishment Section, NNM, latest by **December 31, 2019**.

The applications duly filled in alongwith complete documentation regarding evidences of ISSN/ISBN Nos, Peer-Reviewed, Indexing/Abstracting etc. shall be placed before the Committee constituted for the purpose of verification of the API Scores and the cases complete in all respects, shall thereafter be considered for selection process/interviews.

For the pending cases for promotion from one academic Level/Grade Pay to another Academic Level/Grade Pay under the Career Advancement Scheme provided under the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for Maintenance of Standards in Higher Education, 2010 and its subsequent amendments, the teachers can opt for consideration of their promotion from one Academic Level/Grade Pay to another Academic Level/Grade Pay as per the following:

(a) In accordance with University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.

OR

(b) In accordance with UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for Maintenance of Standards in Higher Education, 2010 and its amendments with relaxation in the requirements of academic Performance Indicators (API) based Performance Based Appraisal System (PBAS) **as specified under clause VII, page 78 of UGC new Regulations, 2018.**

The incumbents not selected earlier by the Selection Committee can only apply after the requisite period as laid down in the UGC Regulations, 2010 and subsequent amendments issued by the UGC from time to time, is completed.

Important Note:

The eligibility of the incumbent shall be reckoned after the outcomes of the decision on the issue which is under consideration of the Ministry
